IN CASE OF MEDICAL EMERGENCY

If I am found unconscious yet alive, but unable to communicate my wishes at the time, and continue in this state, this document shall prevail.

**1. BREATHING and RESUSCITATION:**

Cardiopulmonary resuscitation shall be used as necessary in any case at any time to restore life.
