"I Don't Want You To Wear A Face-Mask"

In [Letter 876a](#) I write about how Yahweh God claimed sovereignty over the COVID-19 disease. In this Letter I will report on how the Lord Holy Spirit led me to meet with a Licensed Mental Health Counselor. This was so I could with talk someone about some of the most painful areas of my life which are documented in these Letters. But it was also in order to further establish His will concerning COVID-19.

Before my first appointment, I had sent a Letter of Introduction to the Counselor to explain that most of what I wanted to say would be more appropriate in an ecclesiastical Church setting, but that such an opportunity had not yet been presented to me.

At this time I also had a fairly comprehensive medical insurance plan (*thank You Jesus*) left over from my previous employment with (G6), under what is called COBRA, or **Consolidated Omnibus Reconciliation Act**, established by Congress many years ago. This Act permits workers to continue in their group medical insurance plan from a previous employer for up to 18 months, provided the worker pays the monthly insurance premium.

My first counseling session was on 19 February of 2020, just before COVID-19 emerged into the popular consciousness of most Americans. After that I attended weekly sessions until my COBRA benefits expired at the end of June 2020, which also coincided with a mandatory face-covering order from the Washington State governor.

Towards the middle of June 2020, when the Lord Holy Spirit began to show me that a face-covering mandate was forthcoming, I asked my Counselor if He would write a face-covering exemption for my mental health situation, as the thought of being forced to do something I was unwilling to do was repugnant to me, and only added to the evil memories I already had from previously being abused by various medical and employment authorities, which is why I went to the counselor in the first place. My Counselor agreed, and wrote the exemption letter, which I still have to this day.

But all this was commanded and prearranged by King Jesus, and administered by the Lord Holy Spirit. It was the Lord who prompted me with His strong hand to seek counseling, and then to request an exemption, and then for the counselor to agree and write the Letter of Exemption.

At about the same time as this, the Lord said to me:

"I DON'T WANT YOU TO WEAR A FACE-MASK".

And He reiterated this phrase more than once. This Word was in addition to my own personal reasons. Later on the Lord gave me a dream to confirm the matter. See [Letter 859a](#).

The Lord then explained to me why the wording He used was important. If He had said something like “you will not wear a face-mask (or covering)”, then there would be no exception to my face-covering exemption. As it is, there have been a few exceptions, and they only pertain to my wife. She requires my assistance to go to her doctor’s appointments, and after the state mandate, healthcare facilities no longer recognized even lawful exemptions, which mine is. So, I had to force myself to set aside my disgust at the face covering mandate for the sake of my wife and her benefit. Other places I discovered that do not recognize lawful exemptions are Starbucks and Costco.

But there was something else about this exemption. Something more that the Lord had in mind. In the course of our conversations together, when I would ask about the the purpose of the face-covering exemption, He would state that:

“I WANT YOU TO HOLD OPEN THE DOOR OF LIBERTY!”

This is because many state governments are willing to sacrifice personal liberty in order to stop the spread of the virus. But God the Holy Spirit, who is the Spirit of Liberty, is countervailing those who would limit Liberty by having me be lawfully exempt from face covering mandates, so that I can prophecy freedom by remaining free.

On a personal note, many years ago I learned at a seminar on biohazard material handling that the standard surgical face covering is essentially ineffective against viruses, as a virus is so small, it can pass through even the tightest woven fabric. Only the equivalent of a certified gas-mask is able to filter out things as small as a virus.

In my personal view, what really drove those states which mandated facial coverings was the effect of what I call “The Hate Trump Syndrome”. This psychological disorder places those so effected in a state of mental confusion. If in 2020, then-President Trump had issued a call for mandatory mask wearing early in the year, the states with Governors of the opposing Democratic party would have done just the opposite, in order to not appear to be in any agreement with President Trump.

But President Trump left whether to wear a face-covering a free choice for each individual within the federal government. The Democratic Governors reacted to this position by doing just the opposite.

Here in Washington State, both the Governor and the State Attorney General were, and to some degree still are, severely afflicted with The Hate Trump Syndrome. So, in June of 2020, face coverings became mandatory, and still are as of this writing.

According to AARP, as of now there are still 13 states which do not require face coverings ([click here for article](#)). As soon as Joe Biden took power as President, he removed the federal individual choice by executive order, making mask-wearing on all federal facilities mandatory for everyone.

Mandatory face coverings continue to be the American gang-sign for those infected with the Hate Trump Syndrome.
