"I Will Make This Happen"

Dear **Yeshua**,

**Monday, 22 March 2021, 8:40PM.**

About 9 months ago, life circumstances required me to obtain new medical insurance to replace the old insurance I had from my employer (G6), which was set to expire on 30 June 2020. Shortly before this I had sent a Letter to Dr. (P8), who had been my personal physician since before my motorcycle wreck, explaining that I would need to part company with his clinic (and out of necessity with him) in order pursue this new direction.

Because of this change, I became independent of corporate medical coverage, and the only other insurance I could find was sold by the State of Washington Healthcare Marketplace.

I settled on the least expensive plan I could find, which was with a Healthcare Maintenance Organization, or HMO. They required me to have a Primary Care Physician, and they stipulated that if I did not choose a doctor from their list, they would choose one for me.

So, I looked on their list and discovered a doctor (P28), who was not far from where I live. I chose (P28), and had my first medical appointment to see him on Monday, 6 July 2020. Before my first appointment, I had sent (P28) a Letter explaining my situation, and that my medical insurance coverage would be changing again a year from then, due to my becoming eligible for early Medicare insurance coverage, on account of my having a Social Security total disability rating.

My most recent appointment with Dr. (P28) was just this last Monday, which was an audio/visual meeting over the internet from my own house.

Because I will be changing medical clinics yet again, I had asked for certain prescriptions to be refilled now, so that I will have enough to carry over while I am between doctors.

One of these prescriptions is for the narcotic pain medicine Hydrocodone (Vicodin). I have been taking Vicodin daily for over twenty years, with no ill side effects or addiction.

Since I will be without a prescriber for an indeterminate period of time, I sent (P28) an electronic note just prior to my appointment, saying that I wished to reduce and discontinue taking Vicodin. Here is part of what I wrote to Dr. (P28):

*"Also, would like to begin to reduce/discontinue HYDROCODONE intake heading into the summer.*

*7 April: 4 per day (120)*

*7 May: 3 per day (90)*

*6 June: 2 per day (60)*

*6 July...: discontinue.*

*Thank you."*

As Dr. (P28) was reading my note online in my hearing, he agreed with my prescription plan and said that:

"I WILL MAKE THIS HAPPEN."

We went over some more items, and then (P28) came back to my prescription requests and said again:

"I WILL MAKE THIS HAPPEN."

While he was saying those words, I had a subtle, quiet Voice indicate in my mind that there was a Larger message being spoken by the doctor. (P28) and I then brought my appointment to completion, and ended the A/V conference.

Later in the day, angel Gabe started to tell me that those words spoken by Dr. (P28) were prophetic words being said by none other than Jesus, the Great Physician, Who was putting His words into the doctor's mouth (see Acts 2:17) .

Jesus was entering into the conversation and sending me a message that He will be helping me in my quest to be totally free of the Medical Industrial Complex (MIC) once and for all. (I had originally become prisoner of the MIC on 15 July 1995. See Letters [261](#) and [38](#)).

**(SPECIAL NOTE-01:** During the online appointment, I saw what appeared to be an infection on the skin of the left side of (P28)'s face. According to the Lord Holy Spirit, I was seeing a representation of Spiritual Leprosy (see [Letter 860d](#)), due to the doctor's sin of racial discrimination against Jews. It is because of this ongoing sin that, at one of my earlier appointments at (P28)'s clinic, I saw a spirit of Nazi-ism affect one of the other workers at the clinic, which caused him, to walk (right in front of me), in a Nazi "Goose-step" fashion. ROE-3 has been applied as indicated, and the problem is being rectified.)

**(SPECIAL NOTE-02:** This will be the third time since I started taking Vicodin that I will have stopped. The first time, which I was prepared for, was for about a two-week period in July of 2020, right before seeing Dr. (P28) for the first time. The second time was about four months ago when, due to a HR induced "communication error" in the doctor's office, my refill request was delayed for one week. For this I was not prepared. In both cases, I suffered no withdrawal symptoms of any kind. Thank You Jesus.)
