Dear **Yeshua**,

In Letter [904a](#) I describe a miraculous event where Yahweh provided 2 extra pain-pills prior to me seeing my doctor to have my pain-pill prescription increased from three hydrocodone caplets to four caplets daily. The Lord God's Word in the matter, which I stated in Letter 904a is:

"YES, I WANT YOU TO HAVE FOUR PILLS."

In this Letter, I will now describe the elaborate process the Lord Holy Spirit took to ensure that His word was fulfilled.

On Wednesday, 19 January 2022, at 9:45AM, I saw my doctor (P33) to talk about increasing my Vicodin dosage. He wanted to ensure that all other avenues of pain remediation had been taken before making any increase to my intake of narcotics.

Dr. (P33) reviewed my past history with medications. I informed him that over the years I had tried many, such as Diclofenac, Trazodone, Neurontin, Lyrica, Baclofen, Lorazepam, and Ambien. From these I experienced moderate to severe side-effects, or ineffectiveness after a period of time.

Then we reviewed other treatments such as physical therapy, exercise, etc. I responded that I had done all of the above, with only temporary results. Then Dr. (P33) asked if I had tried meditation or yoga. I responded that I was a Christian, and that I practiced my own form of prayer and meditation, and I started to quote Psalm 1. I agreed to give Celebrex a try. Outwardly I put on as cheerful a demeanor as I could, but inwardly I began to get dismayed, especially since the Lord had previously stated to me His will in the matter. And I really wasn't getting by very well on only three pills

Dr. (P33) sent the prescription electronically to my local pharmacy. We then parted company, and I left for home.

After I got into my car, I begin to ask the Lord what had just happened. He re-assured me that I would indeed get the 4-pill prescription.

On the way home, I stopped at the pharmacy to confirm their receipt of the new prescription. The pharmacist gave me about a one hour window of time until it was ready, so I left for home to wait.

Upon my return to the drug store, I asked what the out-of-pocket-cost would be. The pharmacy technician responded with a figure that was just short of \$100.00. I indicated to her that it was too expensive, and that I wouldn't be making the purchase.

After I got home, I emailed Dr. (P33) to let him know what had just transpired at the pharmacy, and asked again if he would increase my daily Vicodin count. Within 24 hours Dr. (P33) responded saying he was sorry about the expense, and that he would indeed increase my prescription immediately to 4 caplets daily.

This transpired exactly according to the plan Lord had earlier laid out.

According to the Lord, the reason for the added process was that the Lord wanted me to exercise my ability to "stand my ground", and not be pushed around by the "Medical/Industrial Complex" bureaucracy in which which modern medical doctors are required to participate. Nor did the Lord want me to be badgered into paying an exorbitant amount of money for a simple medication.

All this was according to the will of Yahweh.
