Boy Meets Girl
A Long Time Ago, In A Lifetime Far, Far Away...

0. What follows is a synopsis of parts of my life.

1. Christian Boy wants to find a Christian Wife.

2. Boy moves away from home, in obedience to the Word of God. **See Genesis 2:24.**

3. Boy hears of an upstairs room for rent in a Christian couple's home in Juanita (Kirkland, Wa).

4. Unbeknownst to Boy, Christian Girl had just moved out from upstairs room in Christian House to her own place in Renton shortly before Boy moved into upstairs room in Christian House.

5. Unbeknownst to Boy, Christian House Mother begins to tell Christian Girl of Christian Boy who just moved in.

6. Christian House Mother begins to play "matchmaker", introduces Boy to Girl.

7. Girl loves motorcycles.

8. Boy loves Girl, and Motorcycles.

9. Boy dates Girl.

10. Boy proposes to Girl.

11. Girl says "yes".

12. Boy feels like a complete social "cluts" around Girl.

13. Boy stumbles over words, says hurtful things to Girl.

13a. Boy also fails in other areas.

14. Girl changes mind.

15. Boy and Girl go separate ways.

16. Boy still loves Girl.

17. Girl still loves Boy.

18. Boy and Girl reunite.

19. Girl changes mind again, breaks up with Boy.
20. Boy still loves Girl.
21. Boy and Girl enter into adult life going separate ways.
22. **1981**: Boy and Girl reunite briefly, consider marriage once again.
23. Girl and Boy get Pastoral Marriage Counseling.
24. Boy and Girl change minds, and Girl and Boy part company for the last time (*or so they thought*).
25. Boy moves on with life, loses all track of Girl.
26. Boy finds work as School Custodian, becomes a Job and Career Man of God.
27. Young Career Man meets Young Career Woman at workplace.
28. Young Woman already knows Young Man's Father. Has been taking coffee breaks with him for years.
29. Young Woman falls in love with Young Man.
30. **1985**: Man and Woman date briefly, then marry. **See Proverbs 18:22.**
31. **1986**: Husband and Wife purchase home in North Bend.
32. Mr. and Mrs. continue with careers, become "YURPIES" (Young Rural Professionals).
33. Mr. and Mrs. cannot conceive; try various methods to have child.
34. Mr. continues to seek God, studies Scripture, attends Church. **See Psalm 1, 119:11.**
35. **1990**: Mr. becomes private business man, owns business with business partner. **See 1 Timothy 5:8.**
- 35a. Mr. sees Jesus, who frequently joins Mr. at restaurants for fellowship during meals together. See **Letter 11. See Matthew 5:8.**
36. **1990**: Mrs. continues with her career as School District Media Librarian.
- 36a. Mr. has two dreams about Christian Girl he once dated. Wakes up crying.
37. Mr. and Mrs. like to see movies in theaters. Want to see Batman movie.
38. **3 July 1995**: Mr. goes to local truck-stop cafe to buy newspaper (before internet) to get Batman movie times.
39. Mr. picks up used newspaper from counter.
40. Mr. places food order, then opens newspaper to read... **See Letter 14.**

41. Mr. sees news headline about a killer. He knows the name of the alleged perpetrator.
42. Mr. reads report about the Girl he used to love. She is waiting to be sentenced for felony crimes.
43. Newspaper says that Christian Girl had run into pedestrians with her car - one killed, another severely injured.
44. Mr.'s blood begins to boil, because he knows who was really "... behind this dirty rotten soil."
45. Mr. turns to YAHWEH God, and cries out in GRIEF and ANGER.
46. At this time Father YAHWEH reveals more fully to Mr. that he is a Prophet.
47. The Lord Holy Spirit empowers Prophet with superior knowledge, directions, and instructions.
48. Prophet contacts Christian House Mother to inform her of Christian Girl's tragedy.
49. Father YAHWEH gives to His Prophet prophetic prayers and declarative words for His Daughter.
50. The Prophet writes a prophetic poem for the Christian Girl he still loves:

Our Father Speaks On Behalf of His Daughter

The "ruling" came out
On a Friday, no less.
The judgment was made,
Not a word left to guess.

"Six years to the day
to pay for her crime",
The judge gave the word,
She'll start spending some time.

The Spirit was grieved,
The Son was concerned,
"This Judge does not listen",
The Father observed.

"He spoke out of turn,
Not knowing the peril,
Of using My courtroom
To seek his own evil."

The Son's heart was broken,
He spoke up with a sob,
"Our Daughter was pardoned
The Day I finished the job."

“Our Daughter is hurting”, God said with a tear.
“Let Us make plans
To comfort and heal,
And teach her to hear.”

The Father, The Son, The Spirit;
In Agreement Sublime
Said, “Let’s show her Our love
In a process of Time.”

“We can Each spend a year
Of getting to know her.”
“In teaching her Our ways,
Which others won’t show her.”

“And when We are finished,
We’ll take down the “ruling”,
And tear it in two;
The judge notwithstanding.”

“For the judgment of man
Falls short of Our grace.”
“It tramples, demeans, and
Gets in our Face.”

“But Our Daughter the Beautiful,
The One whom We love,
Will be showered with Blessings,
Peace and Joy from Above.”

“Her soul is our Treasure,
Our highest concern.”
“We’ll give her Our Life,
And Wisdom unlearned.”

“Fear Not!, My Brave One.
You have only begun,
To taste of My Spirit
Of Life in My Son.”

51. The Prophet issues a rebuke to the enemy:

A Man With a Broken Heart

Speaks on Behalf of His Lost Love.

“If you put your hand upon her, your arm will crumble.”
“AND,”
“IF YOU SEEK TO DESTROY HER,
BY YOUR OWN DEVICE
-YOU-
WILL BE DESTROYED.”

52. The Prophet intercedes in prayer for Christian Girl...
53. **Monday, 3 July 1995:** YAHWEH informs Prophet that Christian Girl will get a three year sentence.
54. **Saturday, 8 July 1995:** newspaper headlines read that Christian Girl gets six-year sentence.
55. Prophet turns to YAHWEH and says: “I THOUGHT YOU SAID “THREE”!”
56. “I DID”, YAHWEH replied back to the Prophet.
57. Prophet requests Angelic Honor Guards to be stationed along all avenues where Christian Girl might travel to the prison, along with upgraded Safety, Security, and Protection protocols during her incarceration at the prison.
58. **Friday, 14 July 1995:** Christian Girl reports to King County jail for processing and eventual transfer to Women’s Prison in Purdy, Washington.
59. Prophet goes to secluded spot at an abandoned sawmill to pray. He perceives Heaven, and earth-contiguous spirit-space, and determines that all that could be done, had been done.
60. **Saturday, 15 July 1995:** Prophet leaves house on Honda Magna motorcycle to visit Christian Brother’s house in Monroe.
61. It was a bright, summer Saturday. The ride to his Brother’s house was healing for the Prophet.
62. Satan had become furious at the Prophet’s words which stopped his efforts to destroy the Christian Girl’s life.
63. Satan approaches YAHWEH with his complaint that the Prophet had gotten in his way.
64. YAHWEH allows Satan to vent his fury upon the Prophet and his Wife.

65. That was Satan's undoing...

66. **Saturday, 15 July 1995:** Satan sees the Prophet riding Magna Motorcycle, and quickly devises an ambush scheme in order to destroy the Prophet.

67. The Prophet is a highly skilled and experienced motorcycle rider. He knows how to avoid collisions and other road hazards.

68. As soon as Satan sees the Prophet's return route to his house, Devil sets up his resources for the ambush.

69. At a certain place on the road, at a busy intersection right next to a very popular tourist destination, Satan attacks with Confusion.

70. Satan uses the Confused Driver of a Jeep Cherokee to collide with the Prophet on his Magna Motorcycle.

71. For the first time in his life, the Prophet is blinded and confused; but only for a moment.

72. The Lord Holy Spirit responds immediately, pushing aside the confusion and blindness.

73. Satan breaks the Prophet's bones, causes necrotized muscle tissue, and causes severe nerve damage.

74. Satan further attacks the Prophet in the Hospital. **See Letters 13, 14, 14a, 261.**

74a. Jesus opens Prophet's eyes in Hospital, activating his Seer gift.

75. The Prophet is now disabled, and cannot work or be employed for two and one half years.

75a. The Prophet borders on insanity, calls upon the Name of the Lord for salvation from lunacy.

76. **November 1997- December 2018:** The Prophet suffers severe and disabling chronic pain. Nevertheless, the Prophet overcomes and perseveres and returns to work as a janitor for another 20 years.

77. In **1998**, Satan attacks Prophet's Wife, striking her reproductive organs. Complete hysterectomy is required.

78. In **October 1999**, Prophet transfers to school district closer to home. Jesus re-appears at work, and for 7 months privately tutors the Prophet in all things relating to spiritual warfare. Jesus also introduces the Prophet to a variety of angels who become an integral part of the Prophet's life. **See Letters 23-37.**

78a. During this time, the Lord brings the Prophet back into contact with the Christian Girl. She had been released from prison on appeal, having her sentence reduced from 6 years to 3 years, just as Father YAHWEH had prophesied earlier to the Prophet.

79. Prophet resigns from new job after 7 months, due to high, disabling pain issues.

80. Prophet takes summer of 2000 off to recover from high pain and trauma. Meets the Lord Holy Spirit in human-physical form, along with many angels in human-physical form.

81. Prophet finds work as school district substitute custodian for the **2000/2001 school year**. During this time there is no enemy contact.

82. 17 July 2001 - Prophet finds full-time work as hospital janitor.

82a. 11 September 2001: 9/11.

83. 2002 - Prophet meets Brother Daniel, also a Seer.

84. May 2011 - Prophet is assaulted again by Satan at workplace, who is seeking to destroy Prophet's employment.

84a. Satan's days at-large are now numbered... See **Letter 208.**

85. Satan seeks to destroy the Prophet's ability to work by inciting the Department Manager against the Prophet.

86. Prophet calls on the Name of the Lord once again for salvation. Jesus responds as the Prophet's Advocate. Prophet's employment is saved from the assaults of the Devil. See **Letter 729, 739.** See **Joel 2:32, 1 John 2:1.**

87. 11 July 2011: Prophet writes first Letter to Daniel. See **Letter 1.**

88. Prophet continues to fight against Hell's Resources at the hospital, and to write prophetic Letters to Daniel.

See **Letters 236 (radio silence), 239, 240, 243a, 288, 288a, 310, 411a, 435.**

89. 30 September 2013: Satan appears to the Prophet as a defeated foe; as "...a profane thing." See **Letters 213, 561.**

90. 9 October 2013: Satan is banished to the Sahara and held in confinement until the Rapture. This marks the end of one age (or, one of the days within the Last Days, also known as the "...acceptable year.."), with another age/day soon to follow.

91. 11 January 2014: Angel Gabriel is sent by Jesus to work with the Prophet at the hospital, and stay at the Prophet's house. See **Letter 234, 256, 285.**

91a. The Prophet enters into new phases of warfare. Are these not written about in the Letters To Daniel?
