Revelation 2:24-25
The Stronger Defense

Dear Dan,

Part of the tactics that Satan and his angels use to assault Christians is to sneak up on Believers and, using FOCUSED THOUGHTS as a weapon towards the minds of the Redeemed, attempt to intertwine their own thoughts of evil with those of the Saints. I believe this type of activity falls within the Scriptural category referred to as “the wiles of the Devil” (See Ephesians 6:11). So it was that in the final year of Satan’s rule at (G6), he started using this tactic against me.

One of my favorite podcasts has to do with computer security and other technical things. Both the podcast host and main guest are divorced men, but they are second to none (humanly speaking) in their field of expertise.

And every week while working in (G6d), performing my regular cleaning duties and listening to my iPod, periodically over many months the thought would start to occur to me that since both men are divorced, I should not be listening to their podcast. And embedded in and along with that thought was the inference that I would somehow become guilty if I kept listening to them speak.

I tried to ignore this thought as much as I could. But almost every time I cleaned in (G6d), the thought would come. And I knew I was not the one thinking the thought. Then Scriptures would come to mind that countered this accusation. Scripture teaches that divorce is just one of the many sins that qualify for forgiveness. So after overcoming the Accuser and his thought(s) with this Word I would listen to the podcast anyway. But having to do this so many times over the year was very wearing on my soul.

Because Dr. Missler is not divorced, nor the subject of any other real scandal that could affect me, Satan couldn’t use accusation as a weapon against the K-House audios I would also listen to. So he resorted to a brute force attack, and just flat out started opposing my ability to concentrate on the audio. I would find out later that these Angels of Opposition he uses are part of his satanic armies the Lord would move against later on (see Letter 224).

Additionally to this type of assault, as I stated earlier, for a short time Satan was trying to get me to become his friend, or maybe to deceive me into accepting him as my friend, or both.

One of my big concerns during this time was that I would fall into the trap Jesus warned about in His letter to the Church in Thyatira.

*“Now I say to the rest of you in Thyatira, to you
who do not hold to her teaching and*

***have not learned Satan's

deep secrets,***

*I will not impose any other burden on you,
except to hold on to what you have until I come."*
