A Change Of Intercession

27 November 2014

A little over two weeks ago I noticed that the muscles in the right side of my face would tense and I would clench my jaw a lot for “no reason”, at least none that I knew about or that was apparent. This was an intermittent thing that came and went. So as usual, I waited a few days thinking that whatever the cause was would just go away.

I kind of knew it was some sort of attack from “Uday & Qusay”, and I usually ask angels Gabe or Gabriel to confirm my suspicions. They both agreed that the stress was retribution from the most recent conflict with hell in interceding for (U14) and (CB34).

A little while after we visited the (U19) last summer, the Lord indicated that He was changing the focus of our intercession. While up to that point it was for the World in general, the Lord would now be focusing our intercessory prayers for the Church, the Body Of Christ exclusively (but with some exception should the need arise).

So, after the Lord’s success of shutting down the Dominatrix in (U14) and (CB34)’s life, “Uday & Qusay” decided to up their game against us.

During the wrestling matches we were having, they went for my face, specifically one of my teeth. They somehow knew that I already was scheduled to have a crown replaced early next year due to a cracked tooth (#2 molar), so they focused their attack there. In the meantime I was praying and asking the Lord to reduce the pain and heal whatever was the cause.

Over the weekend the Lord said I should go to the dentist I usually see in (L11) to have it checked, so I called and was seen by him Tuesday morning 25 Nov. He diagnosed an infection in the cracked tooth, and said I needed a root canal, which was referred and scheduled to another dentist in (L12) that specializes in root canals. The (L11) dentist also prescribed an antibiotic to fight the infection, which after ten days will allow me to have the root canal procedure done with minimized risk of further infections.

But in the ensuing conversations I had with my angel family during and after this event Gabriel explained that “they” (“U&Q”), were attempting to corrupt my health in any way they could. Since the tooth was already compromised by being cracked, it was the “weak spot” in the area they were attacking, so it became infected. A vector of entry for bacteria was formed by the fissure between the old crown and the tooth material on which it rested, and found its way down into the roots through the crack in the tooth.

The reason they could get close enough to touch my face was because in the course of interceding, I wrestle with these spirits, in close quarters, hand to hand combat.

But then something else happened. After leaving the dentist's office, a funny noise began to sound in the engine compartment of my S-10. On the drive up the hill to (L6), it lunged a little, and started to squeal. At first I thought it might be the serpentine belt since it is due for replacing, but after some diagnosis on the way back down the hill I discerned that the noise was coming from the transmission. And sure enough, after I parked in the driveway, I tried reverse, which gave no response.

Because (M)'s sister and her family are in town for the Holidays, (M) was scheduled to go up to (L7) for dinner that night. But the only way I could get to work was to borrow her car. After some failed attempts at other ideas, I called in absent from work for that night. And then I knew, before going to bed, that the Lord was going to give us a prayer that would finish "U&Q"'s effect in my life once and for all.

So Tuesday night and into Wednesday morning we worked on audio recording the most recent two memos we sent to you, to convert them into prayers. And Wednesday night we prayed as we worked.

While mopping the floor in one of the surgical suites I felt the presence of "Uday & Qusay", and in the spirit I grabbed them so that I had one in each arm. As soon as I did that I felt them go limp, and they became very weak. I then dropped them to the floor and told them to lay face down with their hands behind their back.

All this was going on while I was mopping the floor and we were listening to the audio prayer, which is also posted on the LTD website under Letter 290.

As I write this, Thursday 27 November 2014 at 11:26PM, I can tell that the antibiotic medicine is working, and that concurrently the spiritual stress of opposing and wrestling with "U&Q" has greatly diminished. I suspect that after I have the root canal dental procedure, scheduled for Wednesday 10 December, I will no longer be assaulted by evil spirits. At least not the same way I have been. It seems clear that they will have all been wrestled into submission by the King, at least as far as we are concerned.

Praise God. Maybe then I can rest finally, which is what the Lord wanted me to do at the beginning and for all of this year.
